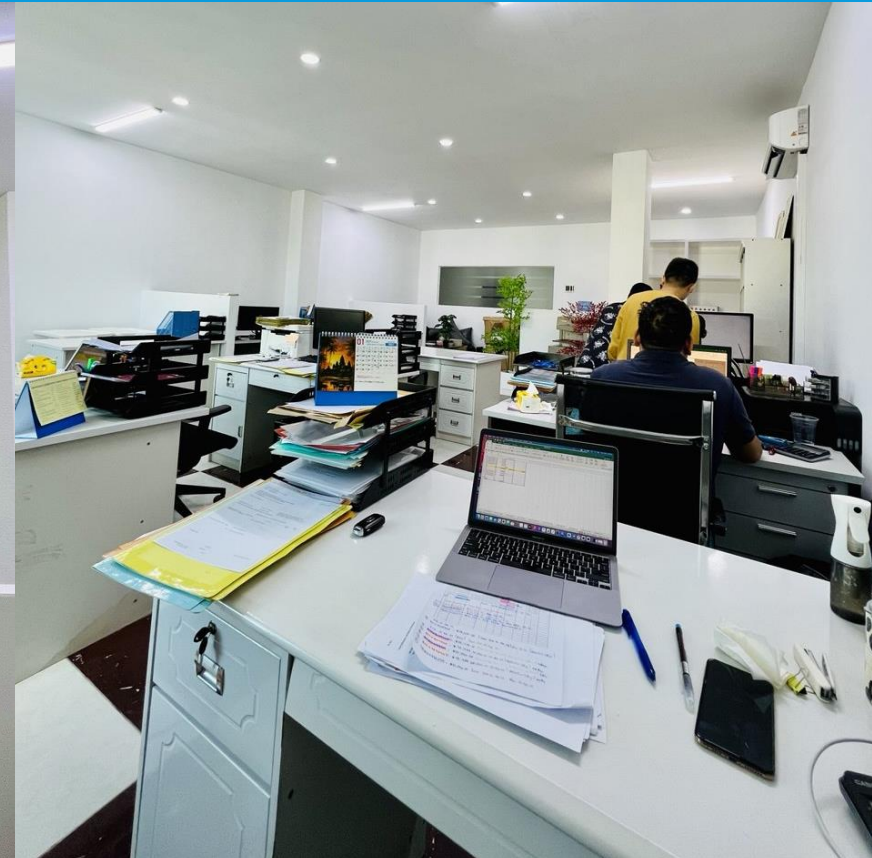

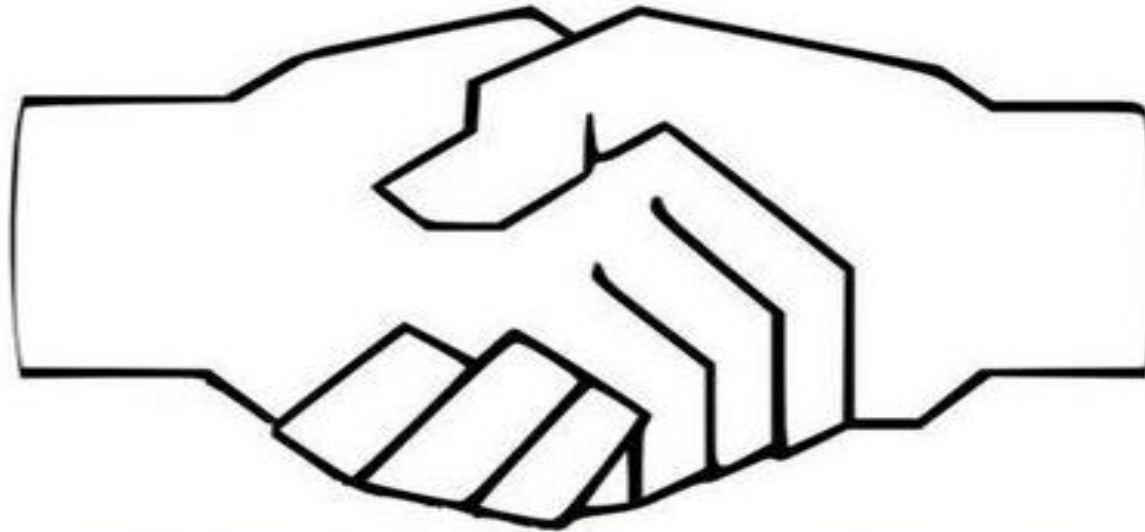
## 4. ALL IN SERVICES
